**7. Variance: Darwin And Pat Kreth-2709 Mentzer Ct.**

*Ethan Lumber representing Darwin & Pat Kreth have applied for a variance for combination of attached and detached accessory buildings of 3,036 square feet vs 1,050 square feet to build a new detached accessory building of 1,656 square feet located at 2709 Mentzer Court, legally described as Lots 5 & 6, Block 3, Woodland Heights 1<sup>st</sup> Addition, City of Mitchell, Davison County, South Dakota. The said real property is zoned Woodland Heights Planned Development District.*

*Jenniges explained It was published in the official city newspaper and neighbors were notified with six responses total in favor and none opposed. The applicant was present to answer questions.*

*The garage will be the same LP siding, shingles, and overhang as the house. There will be rock on the front of the garage and will have a concrete driveway.*

*Motion by Schmitz, Seconded by Osterloo to recommend approval of the Variance Permit. Roll call vote:*

*Chuck Mauszycki Sr lives there currently but he is building a house to move into within the next year. He is dividing the 8 acres incase the new owner doesn't want to purchase it all.*

**10. Plat: Kelley Tracts 1A And 2, A Subdivision Of The South ½ Of The SE ¼ Of Section 36, T 104 N, R 61 W Of The P.M., City Of Mitchell, Davison County, South Dakota; As Requested By City Of Mitchell.**

*Jenniges explained all of the Kelley property was annexed into the City of Mitchell last year. There was an offer accepted by the City of Mitchell but the purchaser wanted some more land with it and this is the agreed upon land. There is an easement for ingress/egress in the owners certificate to get to Tract 2.*
